

## On-line Sweepstakes Rules

- 1. Introduction:** Endeavor Business Media, d/b/a American School & University and Okta ("Sponsor(s)") [is/are] offering the Online Sweepstakes ("Sweepstakes"). **NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING.**

**Sweepstakes may only be entered in or from the 50 United States and the District of Columbia and entries originating from any other jurisdiction are not eligible for entry. This Sweepstakes is governed exclusively by the laws of the United States. You are not authorized to participate in the Sweepstakes if you are not located within the 50 United States or the District of Columbia.**

- 2. Eligibility:** Entrant must be a legal a resident of the fifty (50) United States and the District of Columbia, who is 18 or older as of April 20, 2021 ("Entrants"). [Sponsor(s) may also ask optional questions. Completion of these questions is not required to enter the Sweepstakes.] No automated entry devices and/or programs permitted. Odds of winning depend on the number of eligible entries received. Potential winner(s) will be notified by e-mail or mail on or about January 4, 2022. Each entrant selected as a potential winner must comply

with all terms and conditions set forth in these Official Rules, and winning is contingent upon fulfilling all such requirements.
